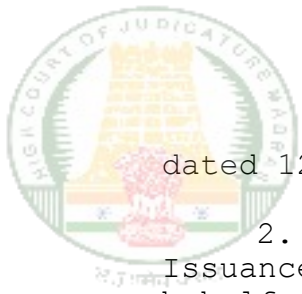

Today, when the matter is listed under the caption 'for Issuance of Patta', the learned Government Advocate appearing on behalf of the respondents submitted that the petitioner application was rejected by order dated 25.03.2022 passed by the second respondent. The learned counsel for the petitioner also ratifies the same.
