Apart from that, as per the orders of the Hon'ble High Court donation by way of things, articles and medical machines etc. is being given to the NGOs and other institutions based on their request.

2.The Official Trustee of Tamil Nadu humbly submits that the Office of the Official Trustee of Tamil Nadu is administering the Trust Estate of Madras Ordinance Pensioned Luscars Charities, Kadapakkam, P.Rajamannar Chetty and Ponnambalam Pillai.
