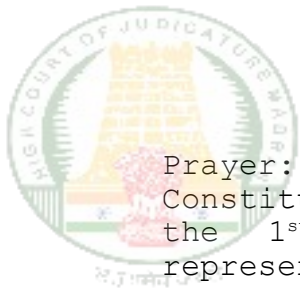

Incidentally, the erection of the tower itself was under police protection provided to R6 in its capacity as a petitioner in CrI.OP.No.17835 of 2019 dated 08.07.2019.
