Considering the fact that the petitioner is regularly complying with the conditional order dated 01.11.2021 in Crl.M.P.No.11134 of 2021 in Crl.O.P.No.15639 of 2021, the condition imposed on the petitioner that the petitioners shall appear before the respondent police on every Monday at 10.30 a.m till filing charge sheet and thereafter as and when required, stands relaxed. However, the petitioner shall appear before the respondent police as and when required for interrogation. Accordingly, this petition is ordered.
