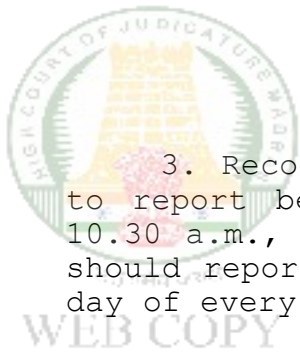

Recording the same, the conditions imposed on the petitioner to report before the Investigating Officer on every Wednesday at 10.30 a.m., until further Orders, is modified to the effect that he should report before the Investigating Officer on 1st and 15th working day of every month at 10.30 a.m., until further orders.
