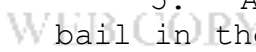
PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioner, who apprehends arrest for the alleged offence under Sections 153 and 505(1)(b) of IPC and Section 66D of IT Act 2008, in Crime No.17 of 2022 on the file of the respondent police, seeks anticipatory bail.

2. Pursuant to the direction given by this Court on 06.04.2022, the petitioner herein has appeared before the respondent police on 08.04.2022 and given the statement. Further, from the interrogation, it appears that the petitioner herein has forwarded the false news with his comments, while the originated of the false news has already been deleted. The petitioner herein has not deleted the tweet as well as his comments.

3. The learned Government Advocate (CrI.Side) submits that the interrogation of the petitioner is required to identify the person who has originated the false information.
