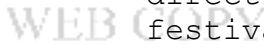

Considering the nature of relief sought for in the Writ Petition, the 3rd respondent is directed to consider the case of the petitioners with regard to conducting Panguni Chithirai festival for the year 2022 and take a decision for conducting the said festival, within a period of two weeks from the date of receipt of copy of this order.

With the above direction, this Writ Petition is disposed of. Consequently, connected Miscellaneous Petition is closed. No costs.
