When the Writ Petition is taken up for hearing, Mr. P.Muthukumar, learned Government Pleader, taking notice for the 1st respondent submitted that as of today, there is no proposal to open a TASMAC shop in the place referred above, hence, the Writ Petition filed by the petitioner is premature and liable to be dismissed.

3. Mr.V.V.Kathiresan, learned counsel appearing for the petitioner submitted that in view of the submission made by the learned Government Pleader appearing for the 1st respondent, the Writ Petition may be closed.

4. The learned Government Pleader further submitted that in the even of the respondents opening a TASMAC shop, it is open to the petitioner to give a fresh representation.

5. Recording the submissions made by the learned Government Pleader appearing for the 1st respondent, since there is no proposal to open a TASMAC shop in the place mentioned in the petition, the Writ Petition stands closed. No costs.
