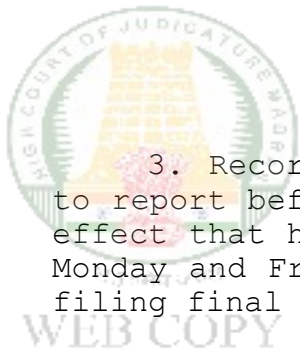

V.BALAMURUGANE, Public Prosecutor for Puducherry on behalf of the Respondent the court made the following order:-

This petition has been filed to relax the conditions imposed in Crl.OP.No.2951 of 2022 dated 21.02.2022.

2. The learned Government Advocate (Crl.Side) appearing for the respondent police has submitted that the investigation is not yet completed, hence, the petition for relaxation is modified to the effect that the petitioner shall report before the Investigating Officer twice in a week instead of daily at 10.30 a.m.



3. Recording the same, the conditions imposed on the petitioner to report before the Investigating Officer daily is modified to the effect that he shall report before the Investigating Officer on every Monday and Friday at 10.30 a.m., till completion of investigation and filing final report.
