2. The Writ Petition has been filed for directing the Respondents to pay salary increment for each year and other service benefits from the date of regularization, viz., 30.03.2006, and pay arrears thereof.

Learned Special Government Pleader appearing for the Respondents, on instructions, states that after the filing of the Writ Petition, the Third Respondent by proceedings no. 498/C2/2004 dated 28.02.2018 had sanctioned the monetary benefits that the Petitioner had sought and its copy has been produced. Learned Counsel for the Petitioner also acknowledges receipt of a copy of the same. In view of the subsequent events, nothing remains for further consideration in this Writ Petition, but if the Petitioner still has any grievance to
