Therefore, this Court is not inclined to entertain these transfer applications filed by the petitioners and the same are dismissed. However, it is open to the petitioners to file appropriate applications before the concerned District Court seeking transfer of the cases.

3. Accordingly, these Transfer Civil Miscellaneous Petitions are dismissed with liberty to file the same before concerned District Judge. No costs. Consequently, connected Miscellaneous Petitions are closed.
