Prayer: Writ Petition filed under Article 226 of the Constitution of India for issuance of a Writ of Mandamus, directing the respondent 1 to issue Patta to the petitioner on representation dated 25.01.2022 for Survey No.100/2C1 part and 100/2C2 in Bharat Nagar, admeasuring to an extent of 880 sq.ft. in 146, Agaram Then Village, Tambaram Taluk, Kancheepuram District situated within the Sub-Registration District of Tambaram and Registration District of Chennai South.

ORDER

This Writ Petition has been filed seeking for issuance of a Writ of Mandamus to direct the first respondent to issue Patta to the petitioner on the representation dated 25.01.2022 for Survey Nos.100/2C1 part and 100/2C2 in Bharat Nagar, admeasuring an extent of 880 sq.ft. in 146, Agaram Then Village, Tambaram Taluk, Kancheepuram District, situated within the Sub-Registration District of Tambaram and Registration District of Chennai South.

2. The case of the petitioner is that he had purchased the aforesaid property through registered Sale Deed, vide Document No.3873/2000. Subsequent to the purchase of the aforesaid property, the petitioner is the absolute owner and is



in possession and enjoyment of the same. However, the Patta stands in the name of the vendor of the petitioner. Therefore, the petitioner made a representation dated 25.01.2022 before the first respondent, seeking for sub-division and Patta transfer in the name of the petitioner. As the said representation made by the petitioner has evoked no response from the first respondent, the petitioner has filed the present Writ Petition.

3. The learned counsel for the petitioner submitted that, it would suffice if this Court issues direction to the first respondent to consider the petitioner's representation dated 25.01.2022 and pass orders on the same, within a particular time frame that may be fixed by this Court.

4. The learned Additional Government Pleader appearing for the respondents has no objection for said order being passed.

5. In view of the aforesaid submissions, this Court, without expressing any opinion on the merits of the case, directs the first respondent to consider the petitioner's representation dated 25.01.2022 and pass appropriate orders, on merits and in accordance with law, within a period of twelve weeks from the date of receipt of a copy of this order.

6. With the above direction, this Writ Petition is disposed of. No costs.
