The petitioner challenges the impugned order of detention in C.M.P.No.24/Goonda/Salem City/2022 dated 07.04.2022 detaining her son as “Goonda”, as contemplated under Section 2(f) of the Tamil Nadu Act 14 of 1982.

The learned Additional Public Prosecutor reports that the order of
