The petitioner challenges the impugned order of detention in proceedings in C3/D.O.No.25/2022, dated 13.04.2022 detaining her husband as “Bootlegger”, as contemplated under Section 2(b) of the Tamil Nadu Act 14 of 1982.

The learned Additional Public Prosecutor reports that the order of detention passed against the detenu has been revoked by the Government by its order in G.O.Rt.No.4302, Home, Prohibition and Excise (IX)
