W.P.No.10341 of 2022: Petition filed under Article 226 of the Constitution of India praying to issue Writ of Certiorarified Mandamus to call for the entire records pertaining to the impugned communication of the 2nd respondent in Na.Ka.No.006380/B1/2022 dated 12.04.2022 and quash the same and to consequently direct the respondents 2 and 3 to permit the petitioner to writ his SSLC (10th Standard Examination) with Hindi Language as Part-I, by exempting the petitioner from writing Tamil Language, as per G.O.Ms.No.37 of the School Education (ERT) Department dated 06.03.2018.

W.P.No.10282 of 2022: Petition filed under Article 226 of the Constitution of India praying to issue Writ of Mandamus directing the respondents 1 and 3 to permit the petitioner to writ the Language Paper-I and Language Paper-II in Hindi Language instead of Tamil Language as mentioned wrongly in the application made by the petitioner before the first respondent by considering the representation dated 22.11.2021.
