Recording the submission of the learned Additional Public Prosecutor, this Writ Petition is disposed of, with a direction to the petitioner to make a representation to the second respondent seeking "No Objection Certificate" for running the business and the second respondent, on receipt of the representation, shall consider the same, and issue "No Objection Certificate", if the petitioner satisfies all the requirements. In the event of "No Objection Certificate" is granted, the respondent shall not, thereafter interfere with the business of the petitioner, until it is run in accordance with law. No costs.
