When the matter is taken up for hearing today, the learned counsel on either side submitted that the subject matter of challenge in these contempt proceedings, had been considered by the Apex Court in Civil Appeal Nos.8921 and 8922 of 2022 (S.L.P.(Civil) Nos.14583 and 14584 of 2022) and by order dated 24.11.2022, the Supreme Court had set aside the
