The learned Government Advocate appearing for the first and second respondents would submit that the Managing Director, Tamil Nadu Co-operative Milk Producers' Federation Limited, Chennai, has passed an order dated 02.12.2013 and the same has been despatched to the petitioner. However, till date, the said order has not been challenged by the petitioner. Therefore, according to the respondents, the petitioner is not entitled for ex-gratia pension.
