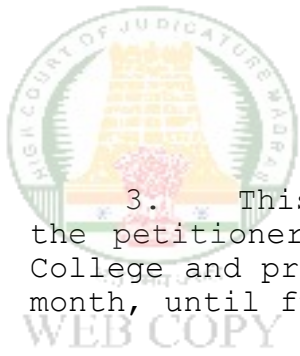

3. This Court, while granting bail, imposed a condition that the petitioner shall obtain a certificate from the Principal of his College and produce the same before the concerned Magistrate once in a month, until further orders.

4. The learned counsel for the petitioner submitted that the petitioner has completed B.E.Mechanical Engineering Degree and also produced his Degree Certificate before the concerned Magistrate, as directed by this Court.

5. Considering the submission made by the learned counsel appearing for the petitioner, the said condition imposed as against the petitioner is deleted.
