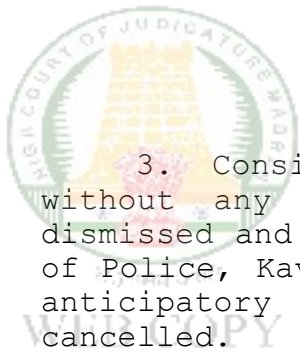

2. The condition imposed by this Court to report before the Inspector of Police, Kaveripakkam Police Station daily at 10.30 a.m. has not been complied by this petitioner. Hence,the petitioner has filed this petition seeking modification.



3. Considering the non-compliance of anticipatory bail condition without any acceptable reason, the petition for modification is dismissed and if the petitioner failed to report before the Inspector of Police, Kaveripakkam Police Station, as ordered by this Court, the anticipatory bail granted to them shall stand automatically cancelled.
