ORDER

This petition has been filed challenging the order passed by the Court below dismissing the petition filed by the petitioners for relaxation of the condition imposed on them while granting anticipatory bail.

2.I have heard the learned counsel for the petitioners and the learned Additional Public Prosecutor accepting notice for the respondent.

3.The Court below dismissed the petition for relaxation only on the ground that the petitioners complied with the condition for 15 days alone.

4.Taking into consideration the facts and circumstances of



the case and the offence, for which, the first information report has been registered against the petitioners, this Court is inclined to interfere with the order passed by the Court below.

5. Accordingly, the Criminal Original Petition is allowed and the impugned order passed the Court below is set aside. The condition imposed on the petitioners while granting anticipatory bail to them in CrI.M.P.No.272 of 2022 on the file of the Principal Sessions Court, Dharmapuri by order dated 23.2.2022 is hereby relaxed and the petitioners shall report before the respondent as and when required.
