This Criminal Original Petition has been filed seeking to direct the respondents to register the complaint on the basis of the petitioner's complaint dated 21.03.2022 in C.S.R.No.165 of 2022 on the file of the 3rd respondent.

2.Mr.N.Muthuvel, learned Government Advocate (Crl.Side) submitted that the enquiry has been conducted and the same has been closed.

3.Heard the learned counsel for the petitioner and the learned Government Advocate (Crl.Side) for the respondents.



4.The Division Bench of this Court in G.Prabhakaran v. The Superintendent of Police, Thanjavur, reported in (2018) 2 LW Cr1 489 and the Hon'ble Supreme Court in its latest judgment rendered by a three Judge Bench in M.Subramaniam v. S.Janaki, reported in (2020) 5 CTC 464, after relying upon Sakiri Vasu's Case, has categorically held that the High Court cannot issue any direction for registration of FIR. High Court can intervene only in extraordinary circumstances and rare cases. It is for the petitioner to pursue his right as per Code.

5.With the above direction, this Criminal Original Petition is closed.
