PRAYER : Petition filed under Article 226 of the Constitution of India praying for the issuance of a Writ of Mandamus or any other appropriate order or direction, directing the respondent to consider my representation dated 12.03.2022 for issuance of patta in my favour based on allotment made in the year 2008 in respect of the property situated at No.19, Ammanoor Village, Winterpet, Arakkonam measuring to an extent of 94 cents, comprised in Survey No.37.

O R D E R

The present petition has been filed seeking a direction to the respondents to consider and pass orders on the petitioner's representation dated 26.03.2022 seeking issuance of patta in respect of the subject land within the time stipulated by this Court.

2. Mr.R.Vigneshwaran, learned Government Advocate takes notice for the respondent.

3. The case of the petitioner is that the petitioner made a representation dated 26.03.2022 before the respondent herein, seeking issuance of patta in respect of the property situated in Survey No.37 measuring to an extent of 94 cents. However, till



date, the same has not been considered. Hence, the present petition is filed seeking the aforesaid relief.

4. Though very many grounds have been raised, learned counsel for the petitioner submits that it would suffice, if this Court issues a direction to the respondents to consider the representation made by the petitioner and dispose of the same in accordance with law, within the time stipulated by this Court.

5. On the above contention, heard the learned Government Advocate appearing for the respondent.

6. In view of the aforesaid submissions, this Court without going into the merits of the case, directs the respondent/Tahsildar to consider the representation dated 12.03.2022 made by the petitioner and dispose of the same in accordance with law, after affording an opportunity of personal hearing to the aggrieved persons if any, within a period of twelve weeks from the date of receipt of a copy of this order.

7. Accordingly, this Writ Petition is disposed of with the aforesaid direction. No costs.
