Learned Government Pleader on instructions confirms that the aforesaid representations are indeed pending.

3. Hence, it would suffice that direction be issued to R3 to hear the petitioner and pass appropriate orders on the aforesaid representations taking assistance of R1, if so required, in accordance with law. Let this exercise be completed within a period of six weeks from today.
