The Writ Petition has been filed seeking to direct the 2nd respondent to grant permission and protection to conduct cultural program scheduled to be held on 05.05.2022 at about 07.00 p.m at Arulmigu Sri Sakthi Mariamman Temple situated at Puthuchampalli, Mettur Dam, Salem District by considering the petitioner representation dated 20.04.2022.



(f) if there is any violation of any one of the conditions imposed, the concerned Police Officer is at liberty to take necessary action, as per law and stop such performance;

(g) similarly, the Police is empowered to stop the programme, if it exceeds beyond the permitted time;

(h) the participants of the programme shall not intake any kind of intoxicating substance or liquor during the programme;

(i) if any untoward incident takes place, the organizers of the programme be made responsible for the same;

(j) the authority concerned shall videograph the entire programme at the cost of the applicant and submit the CD to the S.P concerned;

(k) Organizers shall have to obtain all other required permission from the authorities concerned;

(l) Any other conditions as the authority concerned consider to impose according to the ground reality".

5. The petitioner is also directed to ensure that the conditions are strictly complied with and also to ensure that no law and order problem is created in the course of conducting the programme. Further, the petitioner is directed to pay a sum of Rs.15,000/- (Rupees Fifteen Thousand only) per day to the respondent police towards bundobust charges.

6. The Writ Petition stands disposed of with the above directions.
