COMMON ORDER

The Lower Court, which had granted anticipatory bail, has considered the gravity of the crime and had imposed condition to deposit a sum of Rs.12 lakhs. Later, on the application filed by the petitioner is modified to Rs.6 lakhs. Now the petitioner has moved this Court for further modification.



2. This Court considering the facts of the case the request for further modification is rejected. However for complying the condition time is extended till 16.05.2022. Accordingly, the Criminal Original Petitions stands dismissed.
