PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioner, who apprehends arrest at the hands of the respondent police for the alleged offence punishable under Sections 294(b), 420 & 506(ii) of IPC, in Crime No.16 of 2022, on the file of the respondent police, seeks anticipatory bail.

2. The petitioner herein apprehending arrest on the complaint given by one Sakthi alleging that promising him to get tender from Aavin this petitioner and others have cheated him around Rs.19,50,000/-.

3. The learned counsel for the petitioner would state that it is only a money transaction between the de facto complainant and the petitioner. Taking undue advantage of the fact that the petitioner is working in Aavin, a false complaint has been lodged against him as if he has received the money to arrange the tender.

4. Taking note of the fact that the alleged transaction mentioned in the complaint is of the year 2020, the complaint is given only in the year 2022, this Court is inclined to grant anticipatory bail to the petitioner with certain conditions. Accordingly, the petitioner



is ordered to be released on bail in the event of arrest or on his appearance, within a period of seven days from the date of receipt of a copy of this order, before the Learned Judicial Magistrate No.1, Salem on condition that the petitioner shall execute a bond for a sum of Rs.50,000/- (Rupees Fifty Thousand Only), with two sureties each for a like sum to the satisfaction of the respondent police or the police officer who intends to arrest or to the satisfaction of the learned Magistrate concerned and on further condition that:

(a) if the petitioner failed to surrender before the concerned Magistrate within a period of 7 days from the date of receipt of a copy of this order, this order shall stand automatically cancelled;

(b) the petitioner and the sureties shall affix their photographs and left thumb impression in the surety bond and the Court concerned may obtain a copy of their Aadhar card or Bank pass Book to ensure their identity;

(c) the petitioner shall report before the Investigating Officer daily at 10.30 a.m., until further orders;

(d) the petitioner shall not tamper with evidence or witness either during investigation or trial;

(e) the petitioner shall not abscond either during investigation or trial;

(f) on breach of any of the aforesaid conditions, the learned Magistrate/ Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in P.K.Shaji Vs. State of Kerala [(2005) AIR SCW 5560]; and;

(g) if the accused thereafter absconds, a fresh FIR can be registered under Section 229-A IPC.
