2. Heard the learned counsel appearing for the petitioner.

3. The learned Government Advocate (Crl. Side) appearing for the respondent police submitted that the petitioner is not complying with the conditions imposed by this Court even a single day and till date, the surety was also not executed by the petitioner.



4. Considering the facts and circumstances of the case and also considering the submission made by the learned Government Advocate (Crl. Side) that the petitioner is not complying with the conditions imposed by this Court in Crl.O.P.No.20759/2021 dated 02.11.2021, this Court is not inclined to modify the condition. Accordingly, this Criminal Original Petition is dismissed.
