Prayer in W.P.No.15299 of 2017 : Writ Petition is filed under Article 226 of the Constitution of India, to issue a Writ of Certiorarified Mandamus, to call for the records on the file of the 3rd respondent in connection with his order of rejection in proceedings in A.Thi.Mu.No.1410/2015/A2 dated 29.06.2016 and quash the same and consequently direct the respondent to rectify the pay anomaly by stepping up the pay of the petitioner on par with junior as done in a similar case consequent to judgment dated 18.06.2012 in W.P.No.3698 to 3700 of 2007.

JUDGMENT
(Delivered by PARESH UPADHYAY, J.)

Challenge in this appeal is made to the order dated 13.07.2021 recorded on W.P. No.15299 of 2017. This appeal is by the respondents/ State Authorities.
