The petitioner is the wife of the detenu viz., Anandhan @ Andhoni S/o.Doss, aged 25 years. The detenu has been detained by the second respondent by his order in C3/D.O.No.45/2022 dated 23.04.2022, holding him to be a "Goonda", as contemplated under Section 2(f) of Tamil Nadu Act 14 of 1982. The said order is under challenge in this Habeas Corpus Petition.
