This Revision case has been filed to set aside the Judgment dated 08.04.2022 passed by the learned III Additional Sessions Judge, Tirupattur at Vellore @ Tirupattur in C.A.No.107 of 2019.

2. On perusal of the case, the lower appellate court passed the Judgment in C.A.No.107 of 2019 on 08.04.2022 itself. However, the learned counsel for the revision petitioner has not filed the present case before the Regular Court and filed the same before the Vacation Court without establishing any emergency in this matter.
