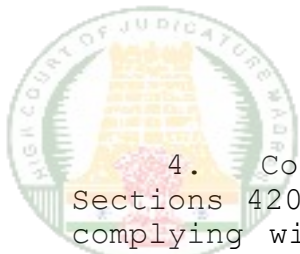

Considering the fact that this is a case raised under Sections 420 and 506(1) of IPC and that the Petitioners are regularly complying with the condition as reported by the learned Counsel for the Petitioners, this Court is inclined to allow the Petition. Further, the petitioners are directed to appear before the Investigating Officer as and when required for interrogation.
