This Criminal Miscellaneous Petition has been filed to modify the condition imposed in Crl.O.P.No.9085 of 2022, dated 25.03.2022, in Paragraph No.3(c) that the petitioners shall report before E-1, Mylapore Police Station daily at 10.30 a.m., until further orders (Near to the residence of the petitioners) instead of the condition that "the petitioners shall report before the Investigation Officer daily at 10.30 a.m., until further orders".



2. The learned Government Advocate (Crl.Side) appearing for the respondent submits that the petitioners sustained injuries and that they are unable to comply with the condition as stated above.
