- (2) Mr.A.Gokulakrishnan, learned Additional Public Prosecutor appearing for the respondents brought to the notice of this Court that the prisoner/detenu, namely Mr.Jailapdeen, son of Ahamed Hussain, died while taking treatment in the hospital on 20.05.2022.
- (3) This being the factum, no further adjudication needs to be undertaken in respect of the grounds raised in this writ petition and accordingly, the writ petition stands disposed of as infructuous.
