Challenge in this Writ Petition is to the notification issued by the 2nd respondent on 07.06.2015 calling for tender for the house situate at A.Jettihalli, Dharmapuri.

2.It appears from the order dated 24.11.2021 made in W.P.No.14686 of 2018 that a subsequent notification dated 27.05.2018 issued for the same housing unit was challenged by the petitioner and this Court has disposed of the said writ petition directing re-allotment of the house to the petitioner for the current market value.
