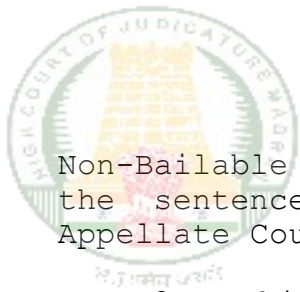
Petition praying that in the circumstances stated therein and in the affidavit filed therewith the High Court will be pleased to Exempt the Petitioner from surrendering before the Judicial Magistrate No.II, Fast Track Court, Coimbatore in C.C.No.08 of 2017 pursuant to the judgment passed by the V Addl District and Sessions Judge at Coimbatore in C.A.No.139 of 2019 dated 28.02.2022, pending disposal of the above CrI.R.C.No.567 of 2022 and thus render justice.

Order : This petition coming on for orders upon perusing the petition and the filed in support thereof and upon hearing the arguments of M/S.T.GNANA BANU, Advocate for the petitioner the court made the following order:-

This petition has been filed seeking for exemption from surrendering before the Trial Court pursuant to the conviction and sentence imposed against the petitioner being confirmed by the appellate Court.

2. Taking into consideration the materials available on record and the grounds raised by the petitioner, this petition is allowed subject to the following conditions.

"The petitioner shall deposit a sum of Rs.3,00,000/- (Rupees Lakhs Only) to the credit of C.C.No.8 of 2017 on the file of the learned Judicial Magistrate, Fast Track Court No.II, Coimbatore, within a period of four weeks from the date of receipt of a copy of this order. If the amount is not deposited within the time stipulated by this Court, it is left open the Judicial Magistrate to issue a



Non-Bailable Warrant against the petitioner and secure him to undergo the sentence imposed by the Trial Court and confirmed by the Appellate Court."

3. This Criminal Miscellaneous Petition is disposed of accordingly.
