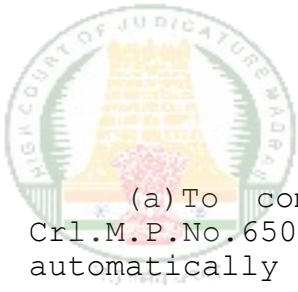

2. Taking into consideration the materials available on record and the grounds raised by the petitioner, this Court is inclined to suspend the substantive sentence imposed against the petitioner subject to the following conditions.



(a) To comply with the conditions imposed by this Court in CrI.M.P.No.6502 of 2022, failing which this petition will stand automatically dismissed.

(b) The petitioner shall execute a bond for a sum of Rs.5,000/- (Rupees Five Thousand only) along with two sureties, each for a like sum, and

(c) The petitioner shall appear before the learned Judicial Magistrate, Fast Track Court No.1, Coimbatore on the first working day of every month at 10.30 A.M., pending disposal of this Criminal Revision Case.

3. This Criminal Miscellaneous Petition is disposed of accordingly. Post the Criminal Revision after six weeks.
