PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioners, who apprehend arrest at the hands of the respondent police for the alleged offences under section **379 of IPC** in Crime No.1388 of 2020, on the file of the respondent police, seek anticipatory bail.

2. The case of the prosecution is that on 02.09.2020, while the defacto complainant along with AD mines were conducting routine check-up at Veerapagoundanur Toll Gate, the petitioners were illegally transported 6 units of Gravel in each of the Taras Tipper Lorry bearing registration No.KL-08-BT-9916 and KL-33-H-1928 without any valid permit. Thereafter, the respondent police seized the lorry along with the Gravel and registered a case against the petitioners.

3.The learned counsel appearing for the petitioners would submit that the petitioners are in no way connected with the alleged offence and they have been falsely implicated in this case. Hence, he pleads for grant of anticipatory bail to the petitioners.



(f) if the accused thereafter absconds, a fresh FIR can be registered under Section 229-A IPC.
