Petition filed under Article 226 of the Constitution of India to

issue a writ of Habeas Corpus call for the entire records relating to the petitioner's father detention under Tamil Nadu Act 14 of 1982 *vide* detention order dated 28.04.2022 on the file of the second respondent herein made in proceedings Memo C.No.02/PBMMSEC Act/IS/2022 and quash the same as illegal and consequently, direct the respondents herein to produce the petitioner's father, *viz.* D.Chinnappa @ Kannan, S/o.Devaraj, aged 39 years, before this Court and set the petitioner's father at liberty from detention, now the petitioner's father is detained at Central Prison, Coimbatore.
