(iii) and for a permanent injunction restraining the defendant from interfering in the internal administration of the Plaintiff Society

(iv) for costs of the suit

2. That a certificate under section 69 of Tamil Nadu Court Fees and Suits Valuation Act, 1955 (Amendment Act) do issue herein, out of and under the seal of this court in favour of The Tamil Nadu Roller Skating



authorising them to receive from the Pay and Accounts Office, High Court Chennai, for a sum of Rs.1,08,830/- (Rupees One Lakh Eight Thousand Eight Hundred and Thirty only) being the entire court fee paid on the plaint by the plaintiff herein.

3. That the O.A.Nos.363 and 364 of 2021 do stand closed.

4. That there shall be no costs of this suit.
