PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioner, who apprehends arrest at the hands of the respondent police for the offences punishable under Sections 498(A), 506(I) of IPC in Crime No. Not known of 2022, seeks anticipatory bail.

2.Today, when the matter is taken up for hearing, the Additional Public Prosecutor appearing for the respondent Police submitted that the petition enquiry in Current Paper No.11/WIT AWPS/INS/2022 is pending against the petitioner.

3.The learned Counsel for the petitioner submitted that the respondent police is harassing the petitioner under the guise of enquiry.

4. Considering the facts and circumstances, the respondent police is directed to conduct enquiry and if any prima facie case is made out against the petitioner, register the F.I.R or close the petition enquiry within a period of two weeks from today. The party is directed to cooperate with the enquiry. It is needless to say that the respondent police shall not take any coercive steps to secure the



accused till the completion of enquiry on the complaint lodged by the defacto complainant.

5. With the above directions, this criminal original petition is disposed of. Consequently, connected Criminal Miscellaneous petition is closed.
