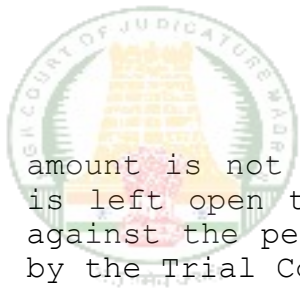
Petition praying that in the circumstances stated therein and in the affidavit filed therewith the High Court will be pleased to grant an order of exemption from surrendering before the trial court in pursuance to the Judgement dated 21.03.2022 made in C.A.No. 18 of 2019 on the file of the Learned Additional District and Sessions Judge, Ariyalur confirming the conviction imposed the Judgement dated 05.11.2019 in STC.No. 258 of 2018 on the file of the learned Judicial Magistrate I, Ariyalur pending disposal of the above Crl.R.C.No.638 of 2022.

Order : This petition coming on for orders upon perusing the petition and the filed in support thereof and upon hearing the arguments of M/S.S.RAJKUMAR, Advocate for the petitioner the court made the following order:-

This petition has been filed seeking for exemption from surrendering before the Trial Court pursuant to the conviction and sentence imposed against the petitioner being confirmed by the appellate Court.

2. Taking into consideration the materials available on record and the grounds raised by the petitioner, this petition is allowed subject to the following conditions.

"The petitioner shall deposit a sum of Rs.1,50,000/- (Rupees One Lakh Fifty Thousand Only) to the credit of S.T.C.No.258 of 2018 on the file of the learned Judicial Magistrate-I, Ariyalur, within a period of four weeks from the date of receipt of a copy of this order. If the



amount is not deposited within the time stipulated by this Court, it is left open to the Judicial Magistrate to issue a Non-Bailable Warrant against the petitioner and secure him to undergo the sentence imposed by the Trial Court and confirmed by the Appellate Court."

3. This Criminal Miscellaneous Petition is disposed of accordingly.
