Dineshkumar @ Dinesh, S/o.Kalaiyaran, aged about 27 years, residing at Mettu Street, Kovilpadhagai, Avadi, Chennai, who is presently undergoing detention in the Central Prison, Puzhal, Chennai, as Goonda under Section 3(1) of the Tamil Nadu Prevention of Dangerous Activities of Bootleggers, Cyber Law Offenders, Drug Offenders, Forest Offenders, Goondas, Immoral Traffic Offenders, Sand Offenders, Slum Grabbers, Sexual Offenders and Video Pirates Act, 1982 (Act 14 of 1982) before this Court and set him at liberty forthwith.

The petitioner challenges the impugned order of detention in No.70/BCDFGISSSV/2022 dated 13.04.2022 detaining her son as "Goonda", as contemplated under Section 2(f) of the Tamil Nadu Act 14 of 1982.
