PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioner was granted anticipatory bail in Cr.O.P.No.2944 of 2022 on the condition that the petitioner shall deposit a sum of Rs.2,00,000/- (Rupees Two Lakhs only) to the credit of Crime No.27 of 2022 within a period of 15 days from the date of receipt of a copy of the order dated 17.02.2022.

2. The learned Counsel for the petitioner submitted that the petitioner is not able to comply with the condition imposed by this Court on 17.02.2022. Therefore, he has filed a petition in CrI.M.P.No.5444 of 2022 for extension of time for complying with the condition imposed by this Court earlier and on 25.04.2022, this Court extended the time to 06.05.2022 for complying the conditions earlier imposed by this Court. However, the copy of the order was not received by the petitioner and as such, he could not comply with the conditions imposed by this Court earlier while he was granted anticipatory bail.
