ORDER

2.The learned Additional Public Prosecutor submitted that there is some civil dispute between the petitioner and the counter party named Hasarudeen and that an enquiry was conducted on the complaint given by the parties and ultimately, the counter party gave an undertaking on 04.04.2022 that he will not interfere with the property and that he will workout his remedy before the appropriate Civil Court. The said undertaking was also produced before this Court.

3.In view of the specific undertaking given before the 2<sup>nd</sup> respondent, no further orders are required to be passed in this petition. Accordingly, this Criminal Original Petition is disposed of.
