The petitioner challenges the impugned order of detention in Cr.M.P.No.20/GOONDA/2022 dated 29.04.2022 detaining his nephew as "Goonda", as contemplated under Section 2(f) of the Tamil Nadu Act 14 of 1982.

The learned Additional Public Prosecutor reports that the order of detention passed against the detenu has been revoked by the Government by its order in G.O.Rt.No.3703, Home, Prohibition and
