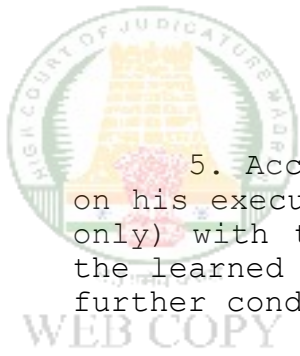
ORDER : The Court Made the following order :-

The petitioner, who was arrested and remanded to judicial custody on 24.04.2022 for the offence under Sections 4(1)(aaa) and 4(1-A) of Tamil Nadu Prohibition Act r/w 328 of IPC in Crime No.264/2021 on the file of the respondent police, seeks bail.

2. The case of the prosecution is that the petitioner was found to be in possession of 110 litres of Puducherry alcohol, which she carried in seven bottles. It is stated that the petitioner is habitually involved in the very same offence.

3.Heard the learned counsel for the petitioner and the learned Government Advocate (criminal side) for the respondent.

4.Taking into consideration of the facts and circumstances of the case and of the fact that the petitioner has already suffered incarceration for 25 days, this Court is inclined to enlarge the petitioner on bail subject to imposing conditions.



5. Accordingly, the petitioner is ordered to be released on bail on his executing a bond for a sum of Rs.5,000/- (Rupees Five Thousand only) with two sureties, each for a like sum to the satisfaction of the learned District Munsif cum Judicial Magistrate, Nannilam, and on further conditions that:-

[a] the sureties shall affix their photographs and Left Thumb Impression in the surety bond and the Magistrate may obtain a copy of their Aadhar card or Bank pass Book to ensure their identity.

[b] the petitioner shall report before the respondent police daily at 10.30 a.m until further orders.

[c] the petitioner shall not tamper with evidence or witness either during investigation or trial.

[d] the petitioner shall not abscond either during investigation or trial.

[e] On breach of any of the aforesaid conditions, the learned Magistrate/Trial Court is entitled to take appropriate action against the petitioners in accordance with law as if the conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in **P.K.Shaji vs. State of Kerala [(2005)AIR SCW 5560]**.

[f] If the accused thereafter absconds, a fresh FIR can be registered under Section 229A IPC.
