PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioner who apprehends arrest at the hands of the respondent police for the offences punishable under Sections 420 & 506(2) of IPC in Crime No.840 of 2021, seeks anticipatory bail.

2. The case of the prosecution is that the defacto complainant has paid a sum of Rs.4,50,000/- to the petitioner in the year 2016 and the said lease period was expired in the year 2020 and a fresh lease agreement was entered between them in the year 2020. Due to the fresh lease, an extra amount of Rs.50,000 was paid to the petitioner. When the defacto complainant demanded the return of lease amount, the petitioner threatened the defacto complainant with dire consequences. Thereby, he cheated the defacto complainant. Hence, this complaint.

3. The learned counsel for the petitioner submitted that the subject properties was already sold out to the third party. Further, the said property was mortgaged with the petitioner while borrowing the loan and not yet redeemed the said property. Therefore, the
