PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioner, who apprehends arrest at the hands of the respondent police for the offences punishable under Sections 294(b), 323, 447 and 506 (i) of IPC and Section 4 of Tamil Nadu Prohibition of Harassment of Women Act in Crime No.88 of 2022 on the file of respondent police, seeks anticipatory bail.

2. The case of the prosecution is that on the date of occurrence, there is a wordy quarrel between the petitioner and defacto complainant, in which the petitioner said to have brutally attacked him with a weapon, thereby, caused serious injury to him. It is a case in counter case. Earlier, the defacto complainant attacked the petitioner and other accused, thereby caused injury. Hence, they have also filed a complaint against the defacto



[e] On breach of any of the aforesaid conditions, the learned Magistrate/Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in P.K.Shaji vs. State of Kerala [(2005)AIR SCW 5560].

[f] If the accused thereafter absconds, a fresh FIR can be registered under Section 229A IPC.
