Therefore, the petitioners are directed to surrender before the *** Special Court for triable Cases under SC/ST Act, Cuddalore**

within a period of fifteen days from today and on such surrender, * The Special Court for triable cases under SC/ST Act, Cuddalore shall deal with the matter on the same day on merits and in accordance with law, after issuing notice to the victims under Section 15 (A) of the SC/ST Act.
